Form must be signed regardless if you are selling anything or not.**

**If you are selling anything you must be in compliance with the law**

You agree to comply with laws and regulations which apply to the operations of your particular concession, as well as the regulations of any other public entities which govern the activities of the concession being operated. NOTE: You are required by California State to have a sellers permit. If you do not have one, please call the State Board of Equalization at 707-427-4800 or go to [www.boe.ca.gov](http://www.boe.ca.gov) There is no cost to the permit.

**Indemnification**

You agree to protect, defend and hold Latino Outreach of Tehama County (LOTC) harmless and against any liability of any kind arising out of your operation of a concession/booth at the 5 de Mayo event. This agreement extends to all injuries and damages to persons and/or property except that caused exclusively by the committee, their officers, agents, employees, or volunteers. This agreement extends to the agents and members of LOTC and their officers, agents, members and/or volunteers harmless.

**Assumption of Risk**

You acknowledge that the operation of an activity at Cinco de Mayo Fiesta 2024 involves a certain amount of risk from accidents which could occur. Nevertheless, you assume the risk of any such accidents or injuries on behalf of your officers, agents and/or employees and agree to hold LOTC and their officers, agents, members and/or volunteers harmless.

**Right to terminate**

LOTC retains the right to terminate on one week's notice provided to you. This agreement may be terminated on even less notice in the event 5 de Mayo Fiesta 2024 is canceled, or the vendor breaches any of the terms hereof. No liability shall result to LOTC as a result of any cancellation of 5 de Mayo Fiesta 2024 or termination of this agreement.

This signed document represents the entire agreement between you and LOTC with respect to operating a booth at 5 de Mayo Fiesta 2024. There are no oral promises or commitments to the terms of which are not included within the written terms hereof.
